

**SUMMARY ANNUAL REPORT FOR
International Union of Operating Engineers • Local 399
Health and Welfare Trust**

This is a summary of the annual report for International Union of Operating Engineers Local 399 Health and Welfare Trust, EIN 36-6198426, for the year ended May 31, 2023. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has a contract with Reliastar Life Insurance Company to pay certain life claims and a contract with The Union Labor Life Insurance Company to pay stop loss claims incurred under the terms of the plan. The total life and stop loss insurance premiums paid for the policy year ending May 31, 2023 were \$128,950 and \$1,236,409, respectively.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan was \$82,468,361 as of May 31, 2023 compared to \$82,572,264 as of June 1, 2022. During the plan year, the plan experienced a decrease in its net assets of \$103,903. This decrease included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$75,704,828 including (but not limited to) employer contributions of \$73,177,032, participant contributions of \$824,843, realized losses of \$2,210,571 from the sale of assets, earnings from investments of \$3,851,635 and other income of \$61,889.

Plan expenses were \$75,808,731. These expenses included \$1,041,914 in administrative expenses and \$74,766,817 in benefits paid to participants and beneficiaries.

You have the right to receive a copy of the full annual report, or any part thereof, upon request. The items listed below are included in that report:

an accountant's report;

financial information and information on payments to service providers;

insurance information including sales commissions paid by insurance carriers;

information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates;

assets held for investment; and

transactions in excess of 5 percent of plan asset.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
